

## Terms and Conditions of “*Win an iPad*” Competition

1. The USQ *Win an iPad* Competition is conducted by the University of Southern Queensland (USQ), Toowoomba, Queensland, 4530, ABN: 40 234 732 081.
2. Information on how to enter form part of these Terms and Conditions. Participation in the Competition is deemed acceptance of these Terms and Conditions.
3. The competition commences at 10:30am (AEST) on 21 MARCH 2012 and concludes 21 MARCH, 2012 at 1:00 p.m. (AEST).
4. Entry is free and limited to current students who during the competition period lodge an entry form in the entry container.
5. All entries become the property of USQ and USQ reserves the right not to return any entries in the Competition to the entrants.
6. The winning entry will be drawn at the 2012 USQ Career Fair at University of Southern Queensland between 1:00 p.m. and 1.30 p.m. 21 MARCH, 2012.
7. The winner of the “*Win an iPad*” entries will be selected by a public drawer and the winner will be the first entrant who is present at the drawer and who responds when their drawn name is called. Only one winning entry will be drawn from all valid entries received by USQ by the closing time and date.
8. The prize for the winning entry will be a 16GB iPad 2 with WiFi and 3G, valued at \$579.00 and will be awarded at the drawer. USQ reserves the right to substitute the prize for another prize of equal value or greater value in the event that the prize is not available.
