1 Attendance requirements:

The final grades for students will be assigned on the basis of the weighted aggregate of the marks (or grades) obtained for each of the summative assessment items in the course.

The exam for this course is a RESTRICTED EXAMINATION, and candidates are allowed access to : *writing materials (non-electronic and free from material which could give the student an unfair advantage in the examination); *calculators which cannot hold textual information (students must indicate on their examination paper the make and model of any calculator(s) they use during the examination.
