RATIONALE

This course is designed to provide students in the Bachelor of Education (Primary & Middle Schooling) with the basic middle years of schooling (Years 4-9) content competencies. This will allow students to appreciate the diverse nature of content in the middle school years. Students also need to develop content knowledge across the key learning areas and build upon their existing knowledge and express themselves adequately in the middle schooling context that will help students to develop confidence and reduce anxiety across the key learning areas in the middle years of schooling (Years 4-9).

SYNOPSIS

Students will be exposed to content in 6 areas regarded as most significant in the Middle Schooling context. These are Science, Mathematics, Expressive Arts, Information Technology, SOSE (Studies of Society and Environment) and Health Studies. **IMPORTANT NOTE: Working with Children: State law in Queensland requires that all adults (including university students, pre-service educators, trainers, vocational teachers, industry educators) working with children under the age of 18, in the State of Queensland*, obtain approval before commencing such work. ASSESSMENT NOTES

- 1 The due date for an assignment is the date by which a student must despatch the assignment to the USQ. The onus is on the student to provide proof of the despatch date, if requested by the examiner.
- 2 Students must retain a copy of each item submitted for assessment. This must be produced within twenty-four (24) hours of receipt of request being made by the examiner. The student must retain this copy until the grade for this course has been finalised.
