RATIONALE

In the 21st century it is no longer just the family, the early childhood service, classroom or neighbourhood that contributes to the growth and development of the child, but multiple contexts that go beyond the immediate environment. The ecologies of a child are unique, complex and very influential. Early childhood educators must be cognisant of the importance of family and other professionals in the well being of a child. The development of partnerships among significant others in the child's life is therefore of utmost importance.

SYNOPSIS

This course focuses on partnerships in early childhood contexts and will assist students to understand the influence of formal and informal collaborative networks and productive partnerships among the community, child, family and the early childhood setting. It will focus on the processes of relationship building and information sharing among families and professionals from the context within which the child lives, learns and grows. The course will enhance student's skills in communicating with others who work with children and heighten students' awareness of the need for and ways of productively fostering working partnerships for the well-being of the child. **IMPORTANT NOTE: Working with Children: State law in Queensland** requires that all adults (including university students, pre-service educators, trainers, vocational teachers, industry educators) working with children under the age of 18, in the State of Queensland*, obtain approval before commencing such work. Many education courses include a practical component (professional experience, project work, research, assessment etc.) that may require engagement with children under the age of 18. It is your responsibility to ensure that you possess a current suitability card (Blue Card) before commencing any practical components of this course. **DO NOT PARTICIPATE IN ANY PRACTICAL EXPERIENCE WITH CHILDREN UNDER 18 UNLESS YOU POSSESS A CURRENT 'BLUE CARD'**.
