RATIONALE

Today, as always, there is an expectation that secondary schools will prepare students for the full range of post-school options. Schools are facing the difficult task of preparing diverse students for an increasingly pluralistic society in an uncertain world, in rapidly changing times. Schools are expected to prepare students for the future, whatever that future may be. To do so, they are expected to work with a variety of organisations, including other educational institutions, community, industry, business and voluntary organisations.

SYNOPSIS

Schools are now recognising that they are no longer the sole repositories of knowledge, and that, to enhance the learning opportunities for students, they must work with outside organisations in collaborative and innovative ways. Many secondary schools are adopting workplace learning programs. As well, school-based apprenticeships and Enterprise Education initiatives link school programs with universities, industry and registered training organisations. Flexible learning approaches and networked learning communities are becoming common in many schools. In this course students will explore and analyse the implications of such initiatives for school organisation and the work of teachers and students. **IMPORTANT NOTE: Working with Children: State law in Queensland requires that all adults (including university students, pre-service educators, trainers, vocational teachers, industry educators) working with children under the age of 18, in the State of Queensland*, obtain approval before commencing such work. ASSESSMENT NOTES

- 1 The due date for an assignment is the date by which a student must despatch the assignment to the USQ. The onus is on the student to provide proof of the despatch date, if requested by the examiner.
