### REQUISITES

### SYNOPSIS

The objective of this course is to introduce students to the legal principles associated with partnerships, associations, trusts and corporations. In particular, students will be exposed to the Partnership Act and Corporations Act in detail and shall be required to be able to describe all appropriate legal principles dealing with such entities and the internal and external relationships thereof.

### OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item(s) that may be used to assess student achievement of an objective are shown in parentheses after each objective. On successful completion of this course, students should be able to:

1. define, analyse, illustrate and apply principles of partnership law (Assignment)
2. describe, analyse and apply the basic principles of law affecting trusts (Assignment)
3. identify problem areas of the law affecting unincorporated bodies and the consequences of having incorporated associations (Assignment, Examination)
4. define, illustrate and apply principles of corporations law including those applicable to: the incorporation of companies; relations with third parties; membership; corporate governance meetings; and procedures of companies; finance of companies; external administration of companies (Assignment, Examination)
5. demonstrate satisfactory skills in communication (Assignment, Examination).

The final grades for students will be assigned on the basis of the aggregate of the weighted marks obtained for each of the summative assessment items in the course.

## ASSESSMENT NOTES

- 1 Assignments: (i) The due date for an assignment is the date by which a student must deposit the assignment in the assignment slot located at the administration building (A-Block) of the Wide Bay campus.
