RATIONALE

This course is designed to provide students in the Bachelor of Education (Primary & Middle Schooling) with the basic middle years of schooling (Years 4-9) content competencies. This will allow students to appreciate the diverse nature of content in the middle school years. Students also need to develop content knowledge across the key learning areas and build upon their existing knowledge and express themselves adequately in the middle schooling context that will help students to develop confidence and reduce anxiety across the key learning areas in the middle years of schooling (Years 4-9).

SYNOPSIS

Students will be exposed to content in 6 areas regarded as most significant in the Middle Schooling context. These are Science, Mathematics, Expressive Arts, Information Technology, SOSE (Studies of Society and Environment) and Health Studies. **IMPORTANT NOTE: Working with Children: State law in Queensland requires that all adults (including university students, pre-service educators, trainers, vocational teachers, industry educators) working with children under the age of 18, in the State of Queensland*, obtain approval before commencing such work. - 1 Attendance requirements:
There are no attendance requirements for this course. To complete each of the assessment items satisfactorily, students must obtain at least 50% of the marks available for each assessment item.
- 3 Penalties for late submission of required work:
If students submit assignments after the due date without prior approval then a penalty of 10% of the total marks gained by the student for the assignment will apply for each working day late.
- 4 Requirements for student to be awarded a passing grade in the course:
To be assured of receiving a passing grade a student must complete and submit all of the assessment items, achieve at least 50% of the total weighted marks for CMA's A-F; at least 50% of the marks for the assignment and achieve at least 50% of the total weighted marks for the course. Should a student fail to achieve 50% of the available marks they will be awarded a supplementary examination and/or assigned additional work to allow them to demonstrate to the examiner that they have achieved the required standard in the objectives assessed by those assessment items.
- 5 Method used to combine assessment results to attain final grade:
The final grades for students will be assigned on the basis of the weighted aggregate of the marks obtained for each of the assessment items in the course.
- 6 Examination information:
There is no examination in this course.
- 7 Examination period when Deferred/Supplementary examinations will be held:
There will be no Deferred or Supplementary examinations for this course.

ASSESSMENT NOTES

- 1 The due date for an assignment is the date by which a student must despatch the assignment to the USQ. The onus is on the student to provide proof of the despatch date, if requested by the examiner.
