### SYNOPSIS

This course is designed to introduce students to the theory and practice of Public Relations at the advanced level. Topics covered include the nature and history of public relations, the tools of public relations, the identification of internal and external publics, the design of public relations programmes and methods of assessing their effectiveness. The student is introduced to the various types of public relations, including corporate communication, community relations, employee relations, financial or investor relations and government relations. The concept of public relations as a management function is explored and the student is introduced to the fundamentals of public relations campaign or programme proposals, the use of objectives, strategies and tactics in public relations planning, and issues management. The course also introduces students to an examination of ethical issues in public relations and the ethical responsibilities of the public relations professional. This course cannot be taken as an elective.

### OBJECTIVES

On successful completion of this course students should:

1. be able to evaluate the foundations of public relations and its development to the present day and be aware of its likely future directions; (assessment item 1 refers)
2. understand the range of functions, activities and specialist areas encompassed by the public relations profession, including corporate communications; (assessment items 1 & 2 refer)
3. have an elementary knowledge of the various organisational settings for the public relations function, including 'in-house' and consultancy or agency; (assessment items 1 & 2 refer)
4. identify the range of communication tools used by public relations practitioners (variously known as Communication Managers, Public Relations Managers, Marketing Communication Managers and so on); (assessment items 2 & 3 refer)

5. be able to prepare a simple Corporate Communication plan on behalf of a client, encompassing initial and evaluative research, objectives, strategy, tools, implementation schedules and a budget. (assessment item 3 refers)
6. be aware of the knowledge and skills necessary to plan, implement and evaluate effective Communication campaigns or programmes; (assessment items 2 & 3 refer)
7. be aware and able to identify the broad scope of public relations and communication beyond stereotypical and functionalist views of publicity, promotion and information dissemination; (assessment items 1, 2 & 3 refer)
8. have an elementary knowledge of the ethical issues faced by the public relations profession. (assessment item 1 refers)

- 1 Attendance requirements:

## **ASSESSMENT NOTES**

- 1 (a) The due date for an assignment is the date by which a student must despatch the assignment to the USQ.
