### RATIONALE

The amount of data and information stored electronically is growing exponentially. At the individual organisational and societal level there is an increasing reliance on information systems to provide this information with the appropriate level of confidentiality, integrity and availability. Hence it is vitally important that business analysts recognise the need to ensure that corporate information and information systems are appropriately secure from unintentional and intentional threats from both authorised and unauthorised users while still maintaining a high level of service.

### SYNOPSIS

The increased reliance on technology to enhance business functions means students must have an understanding of the vulnerabilities and threats which systems face and the controls or countermeasures which can prevent or limit their effect. It is a goal of this course for students to develop skills and knowledge to evaluate Information Security situations, identify specific issues and clearly communicate appropriate recommendations. The ongoing commitment to information systems security that organisations need to take is also stressed in this course.

## OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item/s that may be used to assess student achievement of an objective is/are shown in parentheses after each objective. On successful completion of this course, students should be able to:

1. have a strong understanding of the vulnerabilities and threats relating to information systems and the controls which can be implemented to mitigate their effect (Assignment 1, Assignment 2, Examination)
2. understand the need for information systems security (Assignment 1, Examination)
3. describe various network related threats and controls as covered in this course (Assignment 2, Examination)
4. discuss the legal and ethical issues that can play a part in information systems security (Examination)
5. understand that incidents can still occur and have knowledge of procedures to be put in place to facilitate appropriate incident and disaster response (Assignment 2, Examination)
6. recognise the ongoing commitment to information systems security that is imperative for organisations to maintain reasonably secure information systems and understand the concept of continual improvement (Assignment 1, Assignment 2, Examination).

- 2 Requirements for students to complete each assessment item satisfactorily:  
To satisfactorily complete an individual assessment item a student must achieve at least 50% of the marks. (Depending upon the requirements in Statement 4 below, students may not have to satisfactorily complete each assessment item to receive a passing grade in this course.)
  - 3 Penalties for late submission of required work:  
If students submit assignments after the due date without prior approval of the examiner, then a penalty of 5% of the total marks gained by the student for the assignment may apply for each working day late up to ten working days at which time a mark of zero may be recorded.
  - 4 Requirements for student to be awarded a passing grade in the course:  
To be assured of receiving a passing grade a student must achieve at least 50% of the total weighted marks available for the course.
  - 5 Method used to combine assessment results to attain final grade:  
The final grades for students will be assigned on the basis of the aggregate of the weighted marks obtained for each of the summative assessment items in the course.
  - 6 Examination information:  
This is a restricted examination. Candidates are allowed access to specific materials during the examination. The only materials that candidates may use in the examination for this course are (i) Writing materials: non-electronic and free from material which could give the student an unfair advantage in the examination; (ii) Translation dictionaries: with the Examiner's approval, candidates may, take an appropriate non-electronic translation dictionary into the examination. This will be subject to perusal and, if it is found to contain annotations or markings that could give the candidate an unfair advantage, it may be removed from the candidate's possession until the appropriate disciplinary action is completed.

## **ASSESSMENT NOTES**

- 1 Assignments: (i) The due date for an assignment is the date by which a student must despatch the assignment to the USQ. The onus is on the student to provide proof of the despatch date, if requested by the examiner. (ii) Students must retain a copy of each assignment submitted for assessment. This must be produced within 24 hours if required by the examiner. (iii) In accordance with university policy, the examiner may grant an extension of the due date of an assignment in extenuating circumstances. (iv) The examiner will normally only accept assessments that have been written, typed or printed on paper-based media. (v) Students who do not have regular access to postal services or who

  - 4 Make-up work: Students who have undertaken all of the required assessments in a course but who have failed to meet some of the specified objectives of a course within the normally prescribed time may be awarded the temporary grade: IM (Incomplete - Make up). An IM grade will only be awarded when, in the opinion of the examiner, a student will be able to achieve the remaining objectives of the course after a period of non-directed personal study.
