SYNOPSIS

Business firms extend credit, banks extend loans. The focus of this course is credit analysis and lending. It considers specific aspects such as credit/loan analysis, policy and legal issues, and special types of credits like consumer loans, real estate loans, corporate loans, and international loans. It also deals with issues such as securitisation, loan pricing, problem loans and marketing of loans.

OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item/s that may be used to assess student achievement of an objective is/are shown in parentheses after each objective. On successful completion of this course, students should be able to:

1. outline the basic aspects of lending and the principals of good lending (Assignment, Examination)
2. demonstrate the capacity to undertake and discuss financial statement analysis (Assignment, Examination)
3. explain the rationale for credit scoring models and discuss their development and application (Examination)

4. define and discuss credit risk and explain its measurement and control in relation to individuals, businesses and portfolios (Assignment, Examination)
5. outline and discuss the various issues/loan types/techniques/statistics pertaining to consumer, real estate, corporate, small business and international lending (Examination)
6. describe the legal framework that governs consumer and real estate lending, and outline legal factors that are specific to bankers (Examination)
7. provide an overview of problem loan management: causal factors, remedial actions, statistics etc (Examination)
8. discuss marketing issues in relation to financial services (Examination).

- 1 Attendance requirements:

- 4 Requirements for student to be awarded a passing grade in the course:
To be assured of receiving a passing grade a student must achieve at least 50% of the total weighted marks available for the course.
 - 5 Method used to combine assessment results to attain final grade:
The final grades for students will be assigned on the basis of the aggregate of the weighted marks obtained for each of the summative assessment items in the course.
 - 6 Examination information:
This is a restricted examination. Candidates are allowed access to specific materials during the examination. The only materials that candidates may use in the restricted examination for this course are: writing materials (non-electronic and free from material which could give the student an unfair advantage in the examination); calculators which cannot hold textual information (students must indicate on their examination paper the make and model of any calculator(s) they use during the examination). ASSESSMENT NOTES

- 1 Assignments: (i) The due date for an assignment is the date by which a student must despatch the assignment to the USQ. The onus is on the student to provide proof of the despatch date, if requested by the examiner. (ii) Students must retain a copy of each assignment submitted for assessment. This must be produced within 24 hours if required by the examiner.
