### SYNOPSIS

Law reaches into all corners of modern life and underpins the principles that regulate relationships between individuals and groups. This course introduces students to the foundations of the Australian legal system and institutions, and the mechanics of legal research and analysis. The foundation of the Australian legal system addresses the sources of law; the passage of statutes through parliament, the development of common law through precedent and statutory interpretation. Legal research and analysis provides essential skills in locating the law, analysing the law and communicating the law effectively.

### OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item/s that may be used to assess student achievement of an objective is/are shown in parentheses after each objective. On successful completion of this course, students should be able to:

1. describe the development of the Australian legal system (Online Test)
2. define and discuss the fundamental basis of the legal system and sources of law (Online Test)
3. explain how statute law is made and interpreted (Online Test)
4. explain how common law is developed by judges (Online Test)
5. explain and apply the doctrine of precedent (Assignment)
6. explain and apply the rules of statutory interpretation (Assignment)
7. demonstrate the ability to research and analyse primary, secondary, domestic legal sources in both print and electronic formats (Research Record)
8. apply methods of legal citation (Annotated Bibliography)

9. identify and analyse legal issues and illustrate the ability to apply the principles dealt with in this course in a legal context (Assignment)
10. communicate effectively and clearly the results of legal research and analysis (Research Record, Assignment).
