RATIONALE

The successful practice of the profession of Mechanical Engineering requires an ability to analyse engineering systems and an ability to synthesise new designs. Much of the students work in other courses develops these analytical skills. In addition, the engineer must be able to assess a complex situation, identify the critical elements and develop a workable, cost effective solution. All of this requires considerable self-confidence, and the ability to work with and lead teams. In this course the synthesis of new ideas is developed whilst the student participates in a team-based design and build activity.

SYNOPSIS

This course falls naturally into three parts: Part One consists of a design activity where a small team of students develop a design concept for a device capable of satisfying a broadly specified task. Part Two comprises the procurement of appropriate resources and the construction of the device in accord with the design specification developed in Part One. Part Three covers the testing of the device and encourages the student to reflect on the activities and outcomes of the work conducted in Part One and Part Two above.

OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item(s) that may be used to assess student achievement of an objective are shown in parenthesis. On completion of this course, students should be able to:

1. develop design concepts in accordance with a generic requirement (Design Specification);
2. apply, as appropriate to the design, the operation and construction features of a range of common mechanical devices (Design Specification, Device Performance);
3. co-operate in a teamwork environment (Design Specification, Device Performance, Design Review);

4. identify and explain critical elements in practical situations and propose solutions (Design Specification, Design Review);
5. conduct a simple product development from initial specification to prototype stage (Design Specification, Device Performance, Design Review);
6. observe safety procedures in a workshop environment (Design Specification, Device Performance, Design Review);
7. appraise the performance of a simple mechanical device constructed by the student as part of a team (Device Performance, Design Review).

IMPORTANT ASSESSMENT INFORMATION

- 1 Attendance requirements:

- 3 Penalties for late submission of required work:
If students submit assignments after the due date without extenuating circumstances then a penalty of 5% of the assigned mark may apply for each working day late up to a maximum of ten working days at which time a mark of zero can be recorded for that assignment.
- 4 Requirements for student to be awarded a passing grade in the course:
To be assured of receiving a passing grade students must complete the practical and other activities at a satisfactory standard, as stated in 2 above.
- 5 Method used to combine assessment results to attain final grade:
As P is the only passing grade available for this course, all students who are qualified for a passing grade, under the requirements in 4 above, will be given a grade of P. Other students will be given either a Failing grade or an Incomplete grade.

ASSESSMENT NOTES

- 1 The due date for an assignment is the date by which a student must despatch the assignment to the USQ. The onus is on the student to provide proof of the despatch date, if requested by the Examiner.
