SYNOPSIS

The use of Internet technology in business-to-business (B2B) and business-to-customer (B2C) transactions is growing exponentially. In many cases transactions are initiated and managed via the Internet, but product has to be physically delivered. In these cases the cost of physical delivery is the key element in profitability. This is the subject matter of supply chain analysis. This course introduces the concept of the supply chain, broadly defined to include both design and management aspects. The course also provides a basis for analysing the economic costs and benefits of alternative supply chains.

OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item/s that may be used to assess student achievement of an objective is/are shown in parentheses after each objective. On successful completion of this course, students should be able to:

1. discuss the role of supply chains in the context of e-commerce (Written Assignment, Major Report, Examination)

3. describe alternative decision-making strategies in supply chain design and management (Written Assignment, Major Report, Examination)
4. analyse supply chains applications (Written Assignment, Major Report, Examination).
