RATIONALE

To develop the methodology of statistics in subsequent courses, an understanding of the concepts and theory of probability and probability distributions is required and is provided by this course.

SYNOPSIS

This course introduces students to the elements of probability and distribution theory. The topics include probability, random variables and their distributions, expectation, moment generating functions, standard discrete and continuous distributions, bivariate distributions, transformation techniques and sampling distributions related to the normal distribution.

OBJECTIVES

On successful completion of this course students will be able to:

1. compute probabilities for various situations (Assignment 1, Exam);
2. derive some standard discrete and continuous probability distributions and apply them appropriately (Assignment 2 & 3, Exam);
3. derive the marginal and conditional distribution of random variables (Assignment 2 & 3, Exam);
4. compute the conditional mean and variance from given bivariate distribution (Assignment 3, Exam);
5. understand the concept and applications of the moment generating function (Assignment 2 & 3, Exam);
6. obtain the distribution of transformed variables defined on one and two dimensional space (Assignment 3, Exam);

7. derive the sampling distributions of some statistics (Assignment 3, Exam);
8. use a computer package to solve relevant statistical problems when appropriate (Assignments 1, 2 & 3, Exam).
