REQUISITES

Pre-requisite: BIO1101

RATIONALE

Biology 2 builds on the fundamental concepts of cell structure and function introduced in Biology 1 and provides a theoretical and practical foundation in the biological sciences for both science and non-science students. This course provides a detailed examination of basic animal and plant biology, genetics and evolution which is essential for further study in biology.

SYNOPSIS

The nervous, endocrine, reproductive, cardiovascular, respiratory and renal systems of animals are introduced. This is followed by a study of plant reproductive processes and secondary tissue formation and an overview of plant physiology. We next examine Mendelian genetics in detail. Finally, we explore evolution - the process by which organisms change over time. The residential school is a compulsory component of the external offering of this course.

OBJECTIVES

On completion of this course students will be able to:

1. describe the basic anatomical characteristics and functional features of each of the reproductive, nervous, cardiovascular, respiratory and renal systems (Report 1; Mid-semester Test);
2. demonstrate an understanding of some of the complex nervous and hormonal control mechanisms involved in controlling the reproductive, respiratory, cardiovascular, and renal systems (Report 1; Mid-semester Test);
3. conduct simple physiological experiments and interpret the results of these experiments (Reports 1 & 2);

4. demonstrate an understanding of the basic form and function of the flowering plant (Report 2; End-semester Exam);
5. describe the processes of mitosis and meiosis (End-semester Exam);
6. distinguish between dominant and recessive modes of inheritance (End-semester Exam);
7. demonstrate an understanding of how proteins are formed from genes (End-semester Exam);
8. describe the mechanisms of evolution (End-semester Exam).

ASSESSMENT NOTES

- 9 In order to attend laboratory classes, students must provide and wear appropriate personal protective equipment. This shall include a laboratory coat, closed in shoes, and safety glasses. Such equipment must be approved by supervising staff. Failure to provide and wear the appropriate safety equipment will result in students being excluded from classes.
- 10 Students who have undertaken all of the required assessments in a course but who have failed to meet some of the specified objectives of a course within the normally prescribed time may be awarded the temporary grade: IM (Incomplete-Make-up). An IM grade will only be awarded when, in the opinion of the examiner, a student will be able to achieve the remaining objectives of the course after a period of non directed personal study. Students who, for medical, family/personal, or employment-related reasons, are unable to complete an assignment or to sit for an examination at the scheduled time may apply to defer an assessment in a course. Such a request must be accompanied by appropriate supporting documentation. One of the following temporary grades may be awarded IDS (Incomplete-Deferred Examination); IDM (Incomplete Deferred Make-up); IDB (Incomplete - Both Deferred Examination and Deferred Make-up).
