### SYNOPSIS

## ASSESSMENT NOTES

- 1 (i) The due date for a dissertation chapter is the date by which a student must despatch the chapter to the USQ. The onus is on the student to provide proof of the despatch date, if requested by the Examiner. (ii) Students must retain a copy of each item submitted for assessment. This must be produced within 24 hours if required by the Examiner. (iii) The Examiner may grant an extension of the due date of an assessment in extenuating circumstances. (iv) The Examiner will normally only accept assessments that have been written, typed or printed on paper-based media. (v) The Examiner will not accept submission of assessments by facsimile.
- 2 Referencing in assignments: Harvard (AGPS) is the referencing system required in this course.
