REQUISITES

OTHER REQUISITES

Students must have successfully completed the entire previous year's professional experience courses in order to enrol in this course. Students must be available for a prescribed period of time to undertake a placement in a school or other approved site as required in this course. State law in Queensland (Australia) requires that all adults working/undertaking professional experience/researching with children under the age of 18, in the state of Queensland are required to possess a current suitability card (Blue Card). RATIONALE

Beginning educators report that there are significant differences between their experiences as pre-service educators and those they encounter in the first year of teaching or work in education. The Graduate Internship provides a bridge between the more closely supervised professional experience placements and the first year of the education career. Learning to teach or work as an educator is a process that occurs over time and extends beyond the confines of this program and this course. The internship provides a critical step in this continuum of learning. Each Intern is fully immersed in the role of the educator at the host site. Such immersion has the potential to provide the Intern with an authentic and accelerated understanding of the responsibilities, skills, attitudes and knowledge required of an emerging professional educator.

SYNOPSIS

Students deemed to have demonstrated appropriate levels of competence and professionalism in the program will seek the authorisation of their host site to undertake an Internship. In Queensland schools this will also require an internship authorisation from the Queensland College of Teachers:

equivalent processes may be required in other jurisdictions. Students are also able to elect to undertake the Internship in a non-school setting (such as a community-based education context or in industry) subject to the approval of their specialisation coordinator. In schools or other settings Interns will each undertake lead responsibility for teaching or other work activities equivalent to 50% of the normal load of a fulltime educator at the site. Interns will contribute in a secondary role to the remaining 50% of a fulltime load with the range of duties involving the full repertoires of practice in which educators engage in schools or professional community. The course provides Interns with a minimum of 25 days of site-based education. NOTE: Minimum enrolment numbers apply to this offering. Should enrolments not reach the minimum number required for on-campus study, students may be transferred to the EXT or WEB offering and advised of this change before semester commences.

OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item(s) that may be used to assess student achievement of an objective are shown in parenthesis. On completion of this course students will be able to:

1. take full responsibility for the day to day management of teaching and learning of assigned classes - or the equivalent tasks/role in other approved contexts (Internship Placement)
2. demonstrate a range of effective classroom or workplace management strategies (Critical Incident Analysis and Reflection)
3. exhibit effective resource selection and teaching strategies (Student-led seminar)
4. reflect on and evaluate their own professional practice (Critical Incident Analysis and Reflection)
5. contribute to a variety of school, workplace or community forums, demonstrating appropriate communication skills (Critical Incident Analysis and Reflection; Student-led seminar)
6. demonstrate a willingness and a capacity to be involved in the wider education community (Student-led seminar)
7. demonstrate the ability to form and cultivate professional relationships with students, parents and other staff (Critical Incident Analysis and Reflection)
8. demonstrate knowledge, understanding and application of appropriate personal, professional and academic literacies (Student-led seminar)
9. demonstrate knowledge, understanding and application of appropriate ICT uses in education (Student-led seminar)
10. demonstrate competence in and appropriate use of language and literacy, including spelling, grammar, punctuation and bibliographic referencing. (All assessments)
