SYNOPSIS

Familiarity with electronic devices and circuits is fundamental to electrical engineering. The material covered here will further develop both in breadth and depth that which was covered in the preceding courses, with a significant emphasis on developing design skills. Topics to be covered will include: semiconductor devices (discrete and integrated), logic families, multistage amplifiers, operational amplifiers, active filters, negative and positive feedback, oscillators, power supplies and selected circuits used in communication systems.

OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item(s) that may be used to assess student achievement of an objective are shown in parenthesis. On completion of this course, students should be able to:

1. select and justify common semiconductor devices for given applications (Assignment 1, Assignment 2 and Exam);
2. analyse and design a wide range of electronic circuits (Assignment 1, Assignment 2 and Exam);
3. interpret complex circuit diagrams and standard drawings related to other engineering fields (Assignment 1 and Exam);
4. develop and test electronic circuit designs, and evaluate their performance (Assignment 1, Assignment 2 and Exam).

To satisfactorily complete an individual assessment item a student must achieve at least 50% of the marks or a grade of at least C-. (Depending upon the requirements in Statement 4 below, students may not have to satisfactorily complete each assessment item to receive a passing grade in this course.)
- 3 Penalties for late submission of required work:
If students submit assignments after the due date without extenuating circumstances then a penalty of 5% of the assigned mark may apply for each working day late up to a maximum of ten working days at which time a mark of zero can be recorded for that assignment.
- 4 Requirements for student to be awarded a passing grade in the course:
To be assured of receiving a passing grade in a course a student must obtain at least 50% of the total weighted marks for the course.

The final grades for students will be assigned on the basis of the weighted aggregate of the marks (or grades) obtained for each of the summative assessment items in the course.

ASSESSMENT NOTES
