SYNOPSIS

This course continues the study of property law commenced in Property Law A. It looks at particular issues of property law in greater depth which are important to understanding the commercial context of property transactions. Topics covered will include mortgages and other interests in land, community title schemes and drafting of leases and other documents.

OBJECTIVES

On successful completion of this course students should be able to:

1. describe the extent of land and the rights of landowners
2. describe the scope and meaning of real property
3. describe and apply the law relating to community title schemes, mortgages, easements, landlord and tenant and freehold covenants to given fact situations in order to determine the likely outcome to issues raised
4. demonstrate an ability to draft legal documents creating and transferring interests in property
5. locate and analyse primary law materials and secondary materials (as relevant) while critically reviewing an issue in law relevant to the topics considered in this course
6. demonstrate satisfactory communication skills.

- 1 Attendance requirements:

ASSESSMENT NOTES

- 1 Assignments: (i) The due date for an assignment is the date by which a student must despatch the assignment to the USQ.
