SYNOPSIS

The engineer uses a wide variety of materials from platinum to rocks to construct bridges, automobiles, jet engines, process plants, electronic components, etc. These materials have widely varying properties and consequently it is necessary for the engineer to have a sound working knowledge of the characteristic properties and behaviour during processing/fabrication and in service of the common types of engineering materials. This course extends the basic course "Engineering Materials", to show how the basic principles of materials science are used in the development of contemporary engineering materials. This knowledge is demonstrated through application in material selection and failure analysis of materials.

OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item(s) that may be used to assess student achievement of an objective are shown in parenthesis. On completion of this course, students should be able to:

1. appraise the characteristic properties, applications and behaviour (including strengthening mechanisms) during processing, fabrication and service of a wide range of engineering materials (Assignment 1, Assignment 2, Exam);
2. Systematically specify and justify suitable material(s) for a given application (Assignment 1, Assignment 2, Exam);
3. evaluate the effects of stress fatigue, creep, corrosion, and wear on materials (Assignment 1, Assignment 2, Exam);
4. examine forms and effects of corrosion in metals and review the main methods of corrosion prevention (Assignment 1, Assignment 2, Exam);

5. assess the effects of welding on the properties of a welded component and the methods used to ensure a sound weld (Assignment1, Assignment 2, Exam);
6. apply basic procedures used in the failure analysis of a component and in the selection of a material for a given component (Assignment1, Assignment 2, Exam).

IMPORTANT ASSESSMENT INFORMATION

- 1 Attendance requirements:

- 2 Requirements for students to complete each assessment item satisfactorily:
To satisfactorily complete an assessment item a student must achieve at least 50% of the marks or a grade of at least C-. Students do not have to satisfactorily complete each assessment item to be awarded a passing grade in this course. - 3 Penalties for late submission of required work:
If students submit assignments after the due date without extenuating circumstances then a penalty of 5% of the assigned mark may apply for each working day late up to a maximum of ten working days at which time a mark of zero can be recorded for that assignment.
- 4 Requirements for student to be awarded a passing grade in the course:

- To be assured of receiving a passing grade in a course a student must obtain at least 50% of the total weighted marks for the course.
- 5 Method used to combine assessment results to attain final grade:
The final grades for students will be assigned on the basis of the weighted aggregate of the marks (or grades) obtained for each of the summative assessment items in the course.
 - 6 Examination information:
In a Restricted Examination, candidates are allowed access to specific materials during the examination. The only materials that candidates may use in the restricted examination for this course are: writing materials (non-electronic and free from material which could give the student an unfair advantage in the examination); a non-programmable electronic calculator (students must indicate on their examination paper the make and model of any calculator(s) they use during the examination).
 - 7 Examination period when Deferred/Supplementary examinations will be held:

ASSESSMENT NOTES

- 1 The due date for an assignment is the date by which a student must despatch the assignment to the USQ. The onus is on the student to provide proof of the despatch date, if requested by the Examiner.
