RATIONALE

A knowledge and understanding of the development of music can enrich the understanding of artistic expression and contribute to a greater comprehension of society. Specialised knowledge about the music of contemporary and living composers can help break down the artificial divide between the individual and the fine arts.

SYNOPSIS

This course traces the development of western art-music from 1970 to the present day, with particular emphasis on contemporary composers.

OBJECTIVES

On completion of this course students will have demonstrated:

1. the capacity to understand the development of art-music since 1970;
2. an analytical understanding of the relationship between recent developments in music composition and contemporaneous developments in other fine art disciplines;
3. the capacity to understand and compare the philosophical and aesthetic discourse underlying the various genres of composition from 1970 to the present day;
4. written communication skills appropriate to the discipline by submitting two essays.

IMPORTANT ASSESSMENT INFORMATION

- 1 Attendance requirements:

If students submit assignments after the due date without extenuating circumstances and without prior approval, then a penalty of a maximum of 5% of the assigned mark may apply for each working day late, up to a maximum of 10 working days, at which time a mark of zero can be recorded for that assignment.

To be assured of receiving a passing grade, a student must achieve at least 50% of the total weighted marks available for the course.

The final grades for students will be assigned on the basis of the aggregate of the weighted marks obtained for each of the summative assessment items in the course.

- 9 (a) The due date for an assignment is the date by which a student must lodge the assignment at the USQ. (b) All Faculty of Arts assignments must be lodged in the Faculty Assessment Centre on the Ground Floor of Q Block no later than 12 noon on the due date.
