REQUISITES

RATIONALE

This course provides the student with important music skills which supplement Performance courses. Important elements in the development of a musician are aural awareness and a knowledge of music writing techniques.

SYNOPSIS

This course surveys contrapuntal techniques of the Renaissance and Baroque Periods, with an emphasis on practical exercises in both modal and tonal counterpoint. It also further develops aural acuity relating to pitch, melody, rhythm, two-part work, harmony and form. Each succeeding Music Craft course further develops this acuity.

OBJECTIVES

On successful completion of this course students will have:

1. acquired basic skills in elementary composition skills;
2. further developed their powers of aural observation and awareness.

Translation dictionaries will be subject to perusal and may be removed from the candidate's possession until appropriate disciplinary action is completed if found to contain material that could give the candidate an unfair advantage.
