RATIONALE

Diverse clinical experience is a necessary educational component for student nurses so that they are adequately prepared for contemporary practice. Present-day nursing practice is situated within a variety of health-care settings and it is therefore important to familiarize students with a breadth of clinical experiences, which reflect such diversity. This course will give students the opportunity to plan, practice and evaluate care for individuals, families and communities whilst under the supervision of Health Care Professionals. This clinical course allows for a scaffolding of experiential skills and application of knowledge. The ANMC Competencies are a national regulatory framework to assist nurses to deliver safe and competent care. This course addresses the ANMC Competencies in practice and uses the ANMC Competency framework to assess practical skills. This clinical course facilitates the transfer of skills and knowledge gained in other courses into hands-on delivery of care in the diverse settings of Mental Health Care. Students will be expected to integrate pre and co-requisite theory, such as NUR 2200: Mental Health Nursing; NUR 2199: Clinical Practice AA: Situated Practice and NSC 2000 - Pharmacology to augment clinical knowledge and experience.

SYNOPSIS

It is expected that students will complete 160 hours of clinical practice and 8 hours of briefing/debriefing in a setting pertaining to the care of Mental Health clients. Student placements may include any setting where Mental Health clients are provided care and include rural and remote hospitals, tertiary hospitals, acute inpatient facilities within general hospital settings, community health care centres, correctional facilities, aged care facilities, drug rehabilitation centres. This

course further develops the student nurse in relation to professional interactions with the health care team and patients in mental health settings. The aim is to further develop skills introduced in the first year of the program and to allow authentic practice of those skills covered in the theory course NUR2200 and the Situated Learning Course NUR2199. Strategies that the nurse can use to give holistic, culturally appropriate and effective care are developed and applied, guided by the Standards of Practice for Mental Health Nursing in Australia (ANZCMHN 1995) as a framework for decision making. Reflective practice is anticipated, using an Inquiry-based framework. This course allows the student to develop critical thinking and analysis in relation to evidence-based practice. It aims to allow practice in the conduct of comprehensive and systematic nursing assessment, as well as care planning and implementation at an introductory level. It allows the student to practice the establishment, maintenance and conclusion of therapeutic relationships.

OBJECTIVES

On completion of this course students will be able to:

1. conduct clinical practice, which can be ethically justified and is within scope of practice and in accordance with legislation and common law (ANMC Competency 1 and 2) (Completion of Clinical Placement, Evaluation Report and Reflective Practice + 100% attendance);
2. critically reflect on practice and identify opportunities for further personal and/or professional development (ANMC Competency 4) (Completion of Clinical Placement, Evaluation Report and Reflective Practice + 100% attendance);
3. demonstrate a commitment to "best practice" through referring to valid, reliable evidence and practicing in accordance with this, in response to the clients needs (ANMC Competency 3) (Completion of Clinical Placement, Evaluation Report and Reflective Practice + 100% attendance, Nursing Care for Mental Health Clinical Workbook)
4. demonstrate a sound knowledge of the pathophysiology, pharmacology and nursing care related to theoretical material covered at the time of this course, as evidenced by providing treatment rationales based on clinical reasoning (ANMC Competency 3, 5, 6, 7) (Completion of Clinical Placement, Evaluation Report and Reflective Practice + 100% attendance, Nursing Care for Mental Health Clinical Workbook)
5. identify and discuss the action, dosage, adverse effects and patient teaching related to therapeutic drug regimes (ANMC Competency 3, 5, 6, 7) (Completion of Clinical Placement, Evaluation Report and Reflective Practice + 100% attendance, Nursing Care for Mental Health Clinical Workbook and case based review)
6. integrate and apply knowledge of pathophysiology, pharmacology and the collaborative role of nursing by proposing and demonstrating safe and effective nursing interventions for case presentations of patients with conditions managed during this course, in skills during placement, and in oral form during shift handovers, tutorials and debriefs etc (ANMC Competency 3, 5, 6, 7, 8, 9, 10) (Completion of Clinical Placement, Evaluation Report and Reflective Practice + 100% attendance, Nursing Care for Mental Health Clinical Workbook, and case based review)
7. demonstrate the ability to critically analyse events and intervene appropriately to plan, implement and evaluate safe and appropriate nursing care for clients experiencing compromised health by using systematic data collection and effective clinical reasoning strategies, incorporating evidenced-based practice (ANMC Competency 3, 5, 6, 7, 8, 9 and 10) (Completion of Clinical Placement, Evaluation Report and Reflective Practice, and case based review + 100% attendance)
8. demonstrate effective professional written and oral communication through shift handovers, case study, written documentation, referrals, telephone and face-to-face communication with clients, families and other health professionals (ANMC Competency 8, 9, 10)

- (Completion of Clinical Placement, Evaluation Report and Reflective Practice + 100% attendance, Nursing Care for Mental Health Clinical Workbook)
9. undertake an accurate and comprehensive holistic assessment of clients encountered at the time of this clinical course (ANMC Competency 5, 6) (Nursing Care for Mental Health Clinical Workbook, and case based review)
 10. perform and evaluate clinical procedures with appropriate supervision, which have been introduced in the pre-requisite courses (ANMC Competency 9) (Completion of Clinical Placement, Evaluation Report and Reflective Practice + 100% attendance).

IMPORTANT ASSESSMENT INFORMATION

1 Attendance requirements:

It is the students' responsibility to attend 100% of the clinical placement period (160 hours) and participate appropriately in all activities (such as tutorials, inservice sessions and

- practical work) scheduled for them, and to study all material provided to them or required to be accessed by them to maximise their chance of meeting the objectives of the course and to be informed of course-related activities and administration.
- 2 Requirements for students to complete each assessment item satisfactorily:
To complete the clinical placement requirement, students must submit the reflective component to a satisfactory level, complete 100% attendance and achieve each of the competencies to a satisfactory (S) level, thus achieving the score of (1) allocated for Clinical Practice. To satisfactorily complete the Case Based Review, students must obtain 50% of the allocated mark of 20 for this. To achieve the mark of (1) for the Nursing Care for Mental Health Workbook, students must demonstrate satisfactory achievements in specific core competencies as marked as compulsory to complete, as well as other components in the workbook.
 - 3 Penalties for late submission of required work:
If students submit required assignments late without the approval of the examiner they can expect to be given a score of 0 for the workbook and clinical evaluation tool. A Fail grade for the course will then result.
 - 4 Requirements for student to be awarded a passing grade in the course:
To be assured of a passing grade, students must satisfactorily complete all pieces of assessment, and achieve the (1) allocated for items 1 and 2, and achieve 50% of the marks allocated for item 3.
 - 5 Method used to combine assessment results to attain final grade:
As P is the only passing grade available for this course, all students who are qualified for a passing grade will be given a grade of P. Other students will be given either a Failing grade or an Incomplete grade.
 - 6 Examination information:
There is no Examination in this course.
 - 7 Examination period when Deferred/Supplementary examinations will be held:
As there are no examinations in this course, there will be no deferred or supplementary examinations.
