REQUISITES

OTHER REQUISITES

RATIONALE

Organisations impact greatly on many aspects of our personal and professional lives. They define the way services are delivered, communication channels, policies and standards and how they are monitored, who holds the authority and power, information systems and the level of satisfaction of the people who work in and/or access the services provided by the organisation. Nurses need to know and understand the structure and function of organisations and their impact on care delivery services. Commensurate with this is the understanding that all nurses regardless of their position participate in the roles of manager, leader and/or follower in organisational settings. To successfully incorporate these roles into their professional practice nurses need to have knowledge and understanding of the principles of management, leadership, followership, team building, conflict resolution and quality assurance.

SYNOPSIS

The primary purpose of this course is to facilitate the development of a broad view of the structure and functioning of healthcare organisations, their impact on health care models and the role of nurses as leaders and managers within health care systems.

OBJECTIVES

On completion of this course students will be able to:

1. demonstrate written and oral communication skills by submitting a written assignment and active participation in workshop two
2. identify the major organisational theories (2000-2500 Word Essay);
3. examine the role and relationship of organisational mission statements, philosophies and communication of information on the delivery of health care (Workshop One);
4. recognise how organisational structures, climate and culture impact on nursing (2000-2500 Word Essay);
5. identify the major leadership and management theories (2000-2500 Word Essay);
6. discuss the application of leadership/management theories in practice settings (2000-2500 Word Essay);
7. use critical thinking skills to analyse team building and conflict resolution strategies within the scope of practice of nurse leaders/managers (Workshop Two);
8. develop an understanding of quality assurance and accreditation issues (Workshop Two);

IMPORTANT ASSESSMENT INFORMATION

- 1 Attendance requirements:

ASSESSMENT NOTES
