### REQUISITES

Pre-requisite: (MAT1100 or MAT1102) and (PHY1103 or PHY1104 or PHY1911)

### RATIONALE

The course provides background knowledge of major discoveries relating to the atom and the nucleus of the atom with the aim of providing the student with an understanding of the basic building blocks of matter. This course is of interest to students studying climatology, physics, mathematics, engineering and science education.

### SYNOPSIS

This course discusses topics necessary for the student to gain an understanding of the fundamental building blocks of matter. The concepts studied are related to the structure and properties of both the atom and the nucleus. A range of current applications are discussed in order to clarify and support the theories. A series of practical exercises are undertaken to demonstrate the principles involved.

### OBJECTIVES

On completion of the course students will be able to:

1. demonstrate an understanding of current theories on the fundamental building blocks of matter (Assignment; Reports; Exam);
2. display knowledge on the applications of the theories (Assignment; Reports; Exam);
3. demonstrate skills and knowledge required to perform laboratory experiments safely with appropriate equipment (Reports).

- 1 Attendance requirements:

To be assured of receiving a passing grade a student must achieve at least 50% of the total weighted marks available for the course.
- 5 Method used to combine assessment results to attain final grade:  
The final grades for students will be assigned on the basis of the weighted aggregate of the marks obtained for each of the summative assessment items in the course.
- 6 Examination information:  
Candidates are allowed access only to specific materials during a Restricted Examination. The only materials that candidates may use in the restricted examination for this course are: writing materials (non-electronic and free from material which could give the student an unfair advantage in the examination); calculators which cannot hold textual information (students must indicate on their examination paper the make and model of any calculator(s) they use during the examination). Students whose first language is not English, may, take an appropriate unmarked nonelectronic translation dictionary (but not technical dictionary) into the examination. Dictionaries with any handwritten notes will not be permitted. Translation dictionaries will be subject to perusal and may be removed from the candidate's

possession until appropriate disciplinary action is completed if found to contain material that could give the candidate an unfair advantage.
