RATIONALE

Now that beginning educators have been exposed to the essential elements of curriculum and pedagogy, and are familiar with the key concepts pertaining to general curriculum documentation or to their areas of specialization, this course promotes further investigation into the essential knowledges, skills and competencies necessary for effective planning and teaching in a range of educational contexts from a transdisciplinary perspective. An essential component of this course is that it involves service learning project based in an appropriate educational location.

SYNOPSIS

This course builds on elements of curriculum theory and practice gained in previous curriculum and pedagogy courses and professional experiences through an investigation of negotiated context based curriculum issues using a transdisciplinary approach. For example, authentic planning and assessment, literacy across curriculum areas, equity issues, effective resources, ICTs etc. This course promotes opportunities to investigate transdisciplinary links, nurture proactive practices in a supportive environment, and develop confidence and enthusiasm to implement innovative curriculum plans developed in partnership with a mentor in an appropriate professional context. Students will be expected to be in contact with their school or other context each week.

OBJECTIVES

The course objectives define the student learning outcomes for a course. The assessment item(s) that may be used to assess student achievement of an objective are shown in parenthesis. On completion of this course students will be able to:

1. demonstrate an in-depth knowledge and understanding of their specialist teaching areas (All assessment items)
2. relate in-depth knowledge and understanding to a variety of curriculum related issues such as planning, assessment, resources, inclusivity and technology (All assessment items)
3. demonstrate a capacity for independent inquiry (All assessment items)
4. translate this knowledge and understanding into the professional requirements of the service learning environment (All assessment items)
5. reflect on the experience of the service learning project (project evaluation)
6. demonstrate competence in and appropriate use of language and literacy, including spelling, grammar, punctuation and bibliographic referencing (All assessment items)
