### 3.3.2 INTERNATIONAL AND EDUCATIONAL PARTNERSHIP COMMITTEE (IEPC)

#### ROLE

The International and Educational Partnership Committee is responsible to the Academic Board for matters which affect policy, goals and strategies for internationalisation and educational partnerships (international and domestic) within the University. The Committee will advise the Vice-Chancellor, via provision of its report to the Vice-Chancellor's Committee, on any management-related international and educational partnership issue.

#### FUNCTIONS

The functions of the IEPC are to:

1. provide advice in relation to international and educational partnership matters to Academic Board (and committees therein), University Program Management Committee, Planning Quality and Review Committee and the Multicultural and Transnational Advisory Committee, and other committees as may be appropriate;
2. consider strategic opportunities and policy development options in relation to domestic educational partnerships, including articulation between providers in the domestic sector, and trends in the international education market;
3. provide a University forum for development, feedback, discussion and recommendation of policies and strategies related to the achievement of the University's International Strategy and Institutional Educational Partnerships Strategy especially as they relate to the issues of the appropriate internationalisation of the curriculum improving the international and educational partnership student experience, and the academic achievement, progression and retention rates of international and educational partnership students;
4. review the University's performance - Faculties and non-academic divisions - in implementing USQ's International Strategy and Institutional Educational Partnerships Strategy, including the monitoring of the operational, financial and academic performance of the University's Educational Partnerships;
5. receive and review Educational Partner Academic Program and Operational Performance Reports from Faculties and the International Educational Partner Management Unit (IEPMU) of the International Office;
6. improve the effectiveness of communication and encourage international perspectives in all areas of academic operation through working with relevant Faculty committees; and
7. consider the unique needs of an international student.

8. Director, Global Recruitment and Admissions
9. Chair, Multicultural and Transnational Advisory Committee or nominee
10. Two persons elected by and from the Academic Board.
11. One elected student
