### 3.5.9.1 DISABILITY ADVISORY COMMITTEE

#### ROLE

The Disability Advisory Committee provides a forum for consideration of staff and student equity matters as they relate to disability and oversees the Disability Action Plan process. The Disability Advisory Committee is a sub-committee of the Social Justice Committee.

#### FUNCTIONS

The functions of the Disability Advisory Committee shall be:

- (i) to oversee the implementation of the Disability Action Plan and update the Plan as necessary;
- (ii) to monitor, review and evaluate progress associated with this implementation; and
- (iii) to advise the Social Justice Committee on student and staff equity matters as they relate to disability.

#### MEMBERSHIP

The membership of the Disability Advisory Committee shall be:

- (i) Group Manager, Student Affairs
- (ii) Manager, Counselling, Disability and Health, Student Services
- (iii) Academic Disability Advisers, Faculties (3)
- (iv) Four (4) student representatives nominated by the Coordinator, Disability Resources, of which only Two (2) will be required to attend any particular meeting
- (v) Manager, Student Equity
- (vi) Manager (Operations), Facilities
- (vii) Equal Opportunity Manager
- (viii) Coordinator, Disability Resources
- (ix) Manager, Global Learning Services, Administration Services
- (x) Disability Technical Adviser, Information Technology Services
- (xi) Technical Coordinator, Assistive Technologies, Disability Resources
- (xii) Disability Resource Officer who shall be Executive Officer to the Committee

The Committee shall have the power to co-opt.

#### FREQUENCY OF MEETINGS

The Committee shall meet six times per year, two of which shall be special meetings to consider the implementation of the Disability Action Plan.
