Why is the Reduced Study Load form required?

International students on a student visa are required to maintain full time enrolment to complete their program by the end date on their Confirmation of Enrolment (CoE). USQ is required to monitor each student's enrolment load and take appropriate action when students are not going to complete within the expected duration. Failure to maintain full time enrolment in each compulsory semester without compelling circumstances and/or consultation with the university would constitute grounds for cancellation. This may have an immediate effect on your Student Visa.

Applications must be received by the Faculty program coordinator at least 5 days prior to the last day to drop. Please refer to USQ's important dates.

Studied or studying courses in Semester 3	Students may choose to complete available courses Semester 3. Students may take a reduced study load in a compulsory study period, Semester 1 and / or 2 providing they complete courses in Semester 3.
