

Learning and Teaching Approach for 2022



The following guidance has been developed to support the planning for learning and teaching activities in 2022. The guidance is to be read in conjunction with the USQ COVID Safe Plan, and is subject to change as the pandemic situation evolves.

Approach to Teaching and Learning in 2022

- » All learning experiences are to be designed to facilitate **active engagement** that include opportunities for student-educator, student-student and student-industry interaction and collaboration, whether online or on campus.¹
- » The **Minimum Requirements for Online Teaching and Learning** are to be incorporated into courses so that all USQ students, whether campus-based or fully online, use digital technologies in support of their learning. This is in line with a 'digital first' approach to learning and teaching that maximises the use of digital technologies and provides flexibility and choice for students about when and where to participate.
- » Where 'lectures' are included in a course, they are to be **conducted online** (there will be no didactic lectures timetabled on campus). In line with Minimum Online Requirement 6, recorded online 'lectures' are available on the StudyDesk as 15-20-minute learning chunks with a short activity provided for students to complete at the end of each chunk.
- » **Systems and processes are in place to timetable** all synchronous on-campus and synchronous online learning activities.
- » All on-campus learning and teaching activities are to be **active and interactive**, focusing on learning experiences that are enhanced through face-to-face and hands-on learning experiences (all 'lectures' to be conducted online see point above).
- » **Mandatory on-campus course components** (e.g. practical classes, residential schools, laboratories, studios) that are a requirement for course completion are to be held on campus. These will all be interactive and involve active engagement by students.
- » Staff who facilitate on-campus learning and teaching activities, who support the facilitation of on-campus learning and teaching activities, or who support on-campus students, are to be on campus to provide these activities/support unless otherwise directed by the University COVID Safe Plan. Exceptions to this approach must be approved by the Deputy Vice-Chancellor (Academic Affairs)/relevant Director as applicable.
- » Placements will continue to be managed in conjunction with placement providers, and cohorts will be advised individually of any changes, as necessary.
- » In accord with the implementation of the revised **Assessment Procedure** and **Assessment Types Schedule** (scheduled to go live mid-February 2022):
 - a. Resources and examples will be available to support the design and review of assessment to minimise risks to academic integrity, and
 - b. On-campus paper-based invigilated examinations will not be conducted in 2022. Assessment items scheduled during the formal examination period can include take-home examinations, time-limited online examinations or online viva voce. All online assessments scheduled during the formal examinations period must be timetabled by the Examinations Office. If absolutely necessary in order to meet the requirements of professional accrediting bodies, online invigilated examinations may be held if endorsed by the Deputy Vice-Chancellor (Academic Affairs) or Director USQ College, and approved by the Provost.

COVID Principles

- » The University's primary concern continues to be the **health and safety of our staff and students**, and ensuring that the core business of education and research can continue in a COVID-safe environment. The USQ COVID Safe Plan provides the University with guidance on managing the response to the COVID-19 pandemic. It is complemented by risk management plans for activities that require adjustments due to COVID-19. These should be developed prior to engagement in such activities and should inform the planning, preparation and delivery of such activities. Public Health Directives take precedence over the COVID Safe Plan and risk management plans.
- » The University will maintain its **COVID Safe Plan** which applies to common areas and non-teaching spaces, and each area/function should have a COVID Risk Management Plan approved as appropriate according to the residual risk rating. Key elements of the Plan includes:
 - a. All members of the USQ community **sharing responsibility for the safe use** of University facilities, including abiding by social distancing protocols, maximum room limits, maintaining personal hygiene practices, wearing masks where and when requested, and supporting cleaning protocols as appropriate.
 - b. Encouraging staff and students to **download the SafeZone app**, which can be used to check in and out when attending classes on campus.
 - c. Making **reasonable adjustments for vulnerable students** to continue with their studies.
